### Violations Comments

Violation #16. Food-contact surfaces; cleaned & sanitized

The automatic ware washing machine is not reaching the required temperature of 180F for final rinse sanitization. Highest temperature reached was 168F during wash cycle. Plate simulating thermometer read 151.7F (should be 160F for final surface temperature). Service unit to ensure that the required final rinse temperature is reached and maintained. Unit's data plate specifies 150F minimum for wash and 180F minimum for final rinse. Conduct ware washing at 3-compartment sink until the unit is serviced.

CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.
